#### **MITI Virtual Meeting with Industries (Manufacturing Sector) on “Program Imunisasi Industri COVID-19 Kerjasama Awam-Swasta” (PIKAS)**

TEEAM attended the above virtual meeting which MITI held with the industries this afternoon (12 June 2021), regarding PIKAS – A public-private partnership COVID-19 Industry Immunisation Programme launched as Phase 4 of the National COVID-19 Immunisation Programme (PICK) to accelerate immunisation and expedite herd immunity. Please refer to MITI Media Statement on PIKAS. The virtual meeting was chaired by MITI Deputy KSU, Dato' Seri Norazman Ayob.

**MITI is tasked to co-ordinate the immunisation of employees in the manufacturing sector.** While other Ministries will be responsible for vaccination of employees in their respective sectors, i.e.:

- Construction - Construction Industry Development Board (CIDB) under Ministry of Works.
- Retail - Ministry of Domestic Trade & Consumers Affairs (KPDNHEP).

Registration for this immunisation programme for the manufacturing sector will commence tomorrow, 13 June 2021 and companies can download the application form from MITI website from tomorrow onwards. The completed form is to be submitted directly to MITI at [vaccine4industry@miti.gov.my](mailto:vaccine4industry@miti.gov.my).

PIKAS is implemented through 2 models and company can choose either one that is more convenient.

#### **Model 1: Vaccination at common use PPV nearest to company's location**

Company can opt for Model 1 which uses the current common PPV (Pusat Pemberian Vaksin) located nearest to your location.

Cost estimation:

#### **Model 2: On-site vaccination within factory premise/identified location**

A company or a collective of companies can opt for Model 2 which requires to have at least 1,000 employees. They are required to prepare the site and health professionals/personnel for the vaccination. Kindly refer to the on-site criteria and details in the PIKAS FAQ.

Cost estimation:

**Important Notes:**

- 1) All vaccination cost will be borne by employer.
- 2) Even if employees left the company after the first dose, fee cannot be deducted from employee's salary.
- 3) ONLY FOR MANUFACTURING COMPANY.
- 4) Need to provide manufacturing license and/or SSM registration.
- 5) Strictly for employees and NO family members/dependents/close associates.
- 6) Employees must register for vaccination in MySejahtera.
- 7) Vaccination appointment date & location will be notified to employees via MySejahtera and company representative registered in the application will be notified via email.
- 8) Once vaccination date is informed (Model 1), the company is required to confirm participation to the assigned PIKAS PPV venue and formalise an agreement with the PIKAS PPV operator and make full payment to them before the vaccination date. Company is responsible to arrange logistics for employees to/from the PPV venue.
- 9) MITI notified that vaccination starts from 16 June 2021 onwards.
